

## NOTICE OF PRIVACY POLICY

Kinepict Health Kft. (2092 Budakeszi Kelta köz 5., Hungary; hereinafter referred to as “KINEPICT”) hereby provide you (hereinafter referred to as “User”) with the following notice of privacy policy pursuant the European Parliament’s and Council’s (EU) act no. 2016/679 on informational self-determination and freedom of information that submitting personal data is voluntary and based on the consent of User (hereinafter referred to as: GDPR act) and in accordance with the following notice of privacy policy pursuant to art. 20 of Act 2011 (CXII) of the Hungarian Parliament on informational self-determination and freedom of information (hereinafter referred to as: Infotv.). By accepting the present notice and the terms contained herein, User gives express consent for the handling of his/her/its personal data for purposes of using Kinepict software, regardless of the version online or/and downloaded and used by User (hereinafter referred to as “SOFTWARE”), customer support and customer care in relation thereto. User’s agreement to the handling of personal data for the aforementioned purpose is voluntary and is based – in the event that User does consent – on the GDPR act and in accordance with the art. 5 par. (1) point a) of the Infotv., comprising the following data:

- Last and first name;
- Phone number
- Position held in the company;
- Company or institute name;
- Tax number
- Company headquarters’ address;
- Address
- e-mail address.

User has the option to subscribe to KINEPICT’s newsletter as well, whereas by user’s consent KINEPICT may sent newsletters and/or advertisements in relation to its products, services and/or events. The subscription to the newsletter is not a condition of using the SOFTWARE. User’s agreement to the handling of personal data for the aforementioned purpose is voluntary and is based – in the event that the user does consent – on Act 2008 (XLVIII) of the Hungarian Parliament on the basic requirements and certain restrictions of commercial advertising activities (hereinafter referred to as: Grt.) art. 6 par. (5), comprising the following data:

- name;
- e-mail address; and
- IP address used at the time and date of subscription.

By submitting personal data as stipulated above, User gives his/her/its voluntary consent for the transmission of such data to KINEPICT's parent company, Kinepict Kft. (2092 Budakeszi Kelta köz 5., Hungary), for the purposes of enabling the use of the SOFTWARE and in order to ensure proper customer support and customer care, as well as – provided User did give consent – for the purpose of sending the newsletter.

Any and all data provided by User in accordance with the present notice of privacy policy may solely be handled by appropriate staff of KINEPICT, KINEPICT's parent company and/or its subsidiary who is responsible for customer care, support or the SOFTWARE, as well as those responsible for the maintenance and sending of the newsletter.

The current privacy policy shall be valid from when User's consent is granted until when such consent is withdrawn. User may withdraw his/her/its consent for the handling and processing of all or part of his/her/its personal data for all or some of the designated purposes. By withdrawing his/her/its consent – in relation to handling personal data for SOFTWARE-related purposes – User acknowledges that he/she/it may lose the licence to use the SOFTWARE and/or may lose the right to take advantage of the customer care and services provided by KINEPICT in relation thereto. By withdrawing his/her/its consent – in relation to handling personal data for newsletter-related purposes – KINEPICT will cease to provide User with its newsletter.

The user has the right to request information on his/her/its personal data handled and processed by KINEPICT, the source of such data, the purpose of the data handling and processing, the legal basis and duration thereof, as well as in case of any data processing activity to request information on the person's name, address and actions taken by such persons, also, in the case of any privacy incidents to request information on the circumstances and effects of such incident, on the preventive measures taken, and, in the case of transmission of the personal data concerned, the legal basis and the transmission recipient.

Moreover, User may request information on the handling of his/her/its personal data, request rectification, deletion, blockage, and/or order KINEPICT to cease the handling and processing of all or part of his/her/its personal data for all or some of the designated purposes. User is entitled to withdraw his/her/its consent any time he/she/it sees fit without any reason or justification. User is also entitled to take advantage of any remedies pursuant to the provisions of the Infotv., namely to protest against handling of personal data (provided for art. 21 of the Infotv.) as well as to file a lawsuit or seek remedy (compensation for material or non-

material damages or for indemnity) before the competent courts pursuant to art. 22 of the Infotv.

Pursuant to art. 6 par. (7) of Grt. we hereby notify User that User may unsubscribe from the newsletter by sending a notice of withdrawal of consent for newsletter-related purposes, or a request to prohibit the use of the personal data for advertisement-related purposes to any of the following contacts of KINEPICT:
